- 5. Important: If you wish to vote for any resolution, please put a tick in the box marked "For" or insert the number of shares held by you. If you wish to vote against any resolution, please put a tick in the box marked "Against" or insert the number of shares held by you. If you wish to vote abstention on any resolution, please put a tick in the box marked "Abstain" or insert the number of shares held by you. Where no instruction is given, your proxy will be entitled to vote at his/her discretion.
- 6. This revised form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a corporation Shareholder, this revised form of proxy must be either executed under its common seal or under the hand of its director or other attorney duly authorized in writing.
- 7. If an attending Shareholder or proxy casts a vote of abstention from voting in respect of a resolution, or the vote is not filled or wrongly filled or illegible or abstained from voting, it shall be regarded as invalid votes casted when the Company takes poll in respect of the resolution.
- 8. To be valid, this revised form of proxy and, if such form is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be lodged to the Company's H share registrar in Hong Kong, Tricor Investor Services Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong (for holders of H shares of the Company) or the Company's registered office at No. 789, Renhe Road, Wenjiang District, Chengdu City, Sichuan Province, the PRC (for holders of domestic shares and unlisted foreign shares of the Company) not less than 24 hours before the time appointed for the holding of the AGM (i.e. not later than 10:00 a.m. on Thursday, 17 June 2021) or for the holding of any adjournment.
- 9. Where there are joint registered holders of any share of the Company, any one of such joint holders may attend and vote at the AGM, either personally or by proxy, in respect of such share as if he/she was solely entitled thereto; but if more than one of such joint holders be present at the AGM or at any adjourned meeting thereof (as the case may be), the most senior holder shall alone be entitled to vote, whether in person or by proxy. For this purpose, seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- 10. Shareholders shall produce their identity documents and supporting documents in respect of shares held when attending the AGM. If a corporate Shareholder appoints an authorised representative to attend the AGM, the authorised representative shall produce his/her identity documents and a notarially certified copy of the relevant authorisation instrument signed by the Board or other authorised parties of the corporate Shareholder or other notarially certified documents allowed by the Company. Proxies shall produce their identity documents and the proxy forms signed by the relevant Shareholders or their attorneys when attending the AGM.
- 11. You are reminded that completion and return of the revised form of proxy will not preclude you from attending and voting in person at the AGM or any adjournment thereof if you so wish.
