- To be valid, this form of proxy and, if such form is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be lodged to the Company’s registered office at No. 789, Renhe Road, Wenjiang District, Chengdu City, Sichuan Province, the PRC not less than 24 hours before the time appointed for the holding of the Domestic Shareholders Class Meeting (i.e. not later than 10:00 a.m. on Tuesday, 17 June 2025) or for the holding of any adjournment.
- Where there are joint registered holders of any share of the Company, any one of such joint holders may attend and vote at the Domestic Shareholders Class Meeting, either personally or by proxy, in respect of such share as if he/she was solely entitled thereto; but if more than one of such joint holders be present at the Domestic Shareholders Class Meeting or at any adjourned meeting thereof (as the case may be), the most senior holder shall alone be entitled to vote, whether in person or by proxy. For this purpose, seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- Domestic Shareholders shall produce their identity documents and supporting documents in respect of shares held when attending the Domestic Shareholders Class Meeting. If a corporate Domestic Shareholder appoints an authorised representative to attend the Domestic Shareholders Class Meeting, the authorised representative shall produce his/her identity documents and a notarially certified copy of the relevant authorisation instrument signed by the board of directors or other authorised parties of the corporate Domestic Shareholder or other notarially certified documents allowed by the Company. Proxies shall produce their identity documents and the proxy forms signed by the Domestic Shareholders or their attorneys when attending the Domestic Shareholders Class Meeting.
- You are reminded that completion and return of the form of proxy will not preclude you from attending and voting in person at the Domestic Shareholders Class Meeting or any adjournment thereof if you so wish.
