- If an attending Shareholder or proxy casts a vote of abstention from voting in respect of a resolution, or the vote is not filled or wrongly filled or illegible or abstained from voting, it shall be regarded as invalid votes casted when the Company takes poll in respect of the resolution.
- To be valid, this Second Supplemental Form of Proxy and, if such form is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be lodged to the Company's H share registrar in Hong Kong, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong (for holders of H Shares of the Company) or the Company's registered office at No. 789, Renhe Road, Wenjiang District, Chengdu City, Sichuan Province, the PRC (for holders of Domestic Shares of the Company) not less than 24 hours before the time appointed for the holding of the AGM (i.e. not later than 10:00 a.m. on Tuesday, 17 June 2025) or for the holding of any adjournment.
- Where there are joint registered holders of any share of the Company, any one of such joint holders may attend and vote at the AGM, either personally or by proxy, in respect of such share as if he/she was solely entitled thereto; but if more than one of such joint holders be present at the AGM or at any adjourned meeting thereof (as the case may be), the most senior holder shall alone be entitled to vote, whether in person or by proxy. For this purpose, seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- Shareholders shall produce their identity documents and supporting documents in respect of shares held when attending the AGM. If a corporate Shareholder appoints an authorised representative to attend the AGM, the authorised representative shall produce his/her identity documents and a notarially certified copy of the relevant authorisation instrument signed by the Board or other authorised parties of the corporate Shareholder or other notarially certified documents allowed by the Company. Proxies shall produce their identity documents and Second Supplemental Form of Proxy signed by the relevant Shareholders or their attorneys when attending the AGM.
- This form of proxy is the **Second Supplemental Form of Proxy for the purpose of the supplemental resolution set out in the second supplemental notice of the AGM dated 21 May 2025 and only serves as supplement to the original form of proxy (the “Original Form of Proxy”) for the AGM dated 25 April 2025 and the first supplemental form of proxy for the AGM dated 14 May 2025 (the “First Supplemental Form of Proxy”). This Second Supplemental Form of Proxy should be read in conjunction with the Original Form of Proxy and the First Supplemental Form of Proxy.**
- This Second Supplemental Form of Proxy will not affect the validity of any Original Form of Proxy and the First Supplemental Form of Proxy duly completed by you in respect of the resolutions set out in the original notice of the AGM dated 25 April 2025 (the “**Original Notice**”) and the first supplemental notice of the AGM dated 14 May 2025 (the “**First Supplemental Notice**”). If you have validly appointed a proxy to attend and act for you at the AGM but do not complete and deliver this Second Supplemental Form of Proxy, your proxy will be entitled to vote at his/her discretion on the resolution numbered 15 set out in the second supplemental notice of the AGM. If you do not duly complete and deliver the Original Form of Proxy and/or the First Supplemental Form of Proxy but complete and deliver this Second Supplemental Form of Proxy and validly appoint a proxy to attend and act for you at the AGM, your proxy will be entitled to vote at his/her discretion on the ordinary resolutions numbered 1 to 14 and the special resolutions numbered 1 to 6 set out in the Original Notice and the First Supplemental Notice.
- If the proxy being appointed to attend the AGM under the Second Supplemental Form of Proxy is different from the proxy appointed under the Original Form of Proxy and/or the First Supplemental Form of Proxy and both proxies attended the AGM, the proxy validly appointed under the Original Form of Proxy and/or the First Supplemental Form of Proxy shall be designated to vote at the AGM. If the proxy being appointed to attend the AGM under the First Supplemental Form of Proxy is different from the proxy appointed under the Original Form of Proxy and both proxies attended the AGM, the proxy validly appointed under the Original Form of Proxy shall be designated to vote at the AGM. Completion and delivery of the Original Form of Proxy, the First Supplemental Form of Proxy and/or the Second Supplemental Form of Proxy will not preclude you from attending and voting at the general meeting if you so wish. In such event, the relevant instrument appointing a proxy shall be deemed to be revoked.
